



My child is making progress




The school values my views, wishes and feelings with regards to the provision for my child




The school involves my child in decisions about their provision (pupil voice, conversations, knowing my child's strengths and areas for development etc)




The school involves me in decisions about the provision for my child




The school has a good understanding of my child's individual needs




I know what support is in place to ensure my child makes progress




I know who the SENCo (Inclusion Lead) is and how to contact them




The class teachers are able to support me with any questions I may have relating to my child's SEN journey (including directing to INCo where appropriate)




When I have concerns regarding my child, they are addressed quickly and effectively




Where applicable, the school has directed me towards additional services and agencies to help me support my child (GP, Speech & Language, Advisory Teachers, Family Centre etc)

I have accessed the Inclusion section of the school website (including SEN information)




I would like to expand on some of the answers above / I have the following further comments to make...




I have received a copy of my child's termly Individual Provision Plan from their class teacher

Keeping parents informed

Parents are included in discussions and decisions about each child. The SEN team have great understanding and empathy for parents and the children. Interventions are gentle and appropriate. Objectives and steps to get there are clear and attainable. Measures in place are communicated to the whole team so there have been no misunderstandings or deviations from the plan.

We're very pleased with the SEN provision provided. It might be good to have a parent network/forum to connect with other parents and children with similar issues. This would help reassure parents and help us support each other in the community.

Actions / Response to Feedback (Dec 2023):

1) *Parent not having received a copy of Individual Provision Plan:* All parents for children on the SEN Register have received and signed copies of their child's provision plan, however this survey was also sent to families of Nursery children who have had significant input from the Inclusion Team. As their child(ren) is not formally on the SEN Register an IPP is not yet in place, however we have introduced a new Provision Plan for Nursery children which has now been shared with all of the relevant families.

2) *The school involves my child in their provision:* This is already a focus for the year and something we are working on with regards to how we can ensure the younger children know about the additional support they are receiving. We are also working on new ways of collecting Pupil Voice for children who are non speaking.

3) *Parent Network / Forum:* This was trialled last year but with minimal numbers. Plans / dates in place for the new year to reintroduce this.
